1. Meeting the child's needs.

Date of the following examination:

Health: physical development – height, weight, problems, measures taken, annual medical examination, vaccination.

Education: achievements, problems, their conformity with the age, form of mastering of educational programs, kind of educational institution, additional education (specify what supplementary education institutions the child attends).

Ensuring development of the child's abilities: the child's access to games, hobby groups, sports.

Appearance and adaptation to social demands: conformity of clothes with the age, gender, culture, religion, personal hygiene, adequacy of the child's behaviour in different environment, perception of advices of the adoptive parents

Self-servicing skills: ability to dress, eat, solve social and domestic problems.

2. Ability of the adoptive parents to meet the child's needs.

Principal care: meeting the child's basic needs – in food, housing, hygiene, clothes, and medical aid.

Protection of the child: no access to hazardous objects at home, medicines, electrical appliances, gas, etc., assessment of risk of injury to the child both at home and anywhere.

How do the adoptive parents manifest affection, is there a favour required for the child to feel emotional warmth.

3. Family and environment factors.

Family history: influence of family history of the adoptive parents upon the child's life at present – who lives in the house and how it influences the child, changes in the family composition at present and in the past, family values and traditions, nature of relations of the adoptive parents with relatives and between themselves, influence of such relations on the child.

Social connections of the family: with neighbours, acquaintances, contacts of the child with peers, teachers, educators.

Housing.

Living conditions of the family:

total and residential area; housing equipping and amenity; sanitary and hygienic condition – good, satisfactory, unsatisfactory; additional information about living and financial conditions.

Availability of: separate room, bed, play pit, activities, toys, books, day regimen and food/

Employment: who works, employment or unemployment, working hours, employment changes and its influence upon the child.

Income: sufficient or not, how it influences the child, is the child provided with anything necessary (clothes, footwear, domestic textile, toys, school supplies and writing materials), payment for special-purpose hobby groups, schools.

Facilities at the place of residence: educational institutions, cultural establishments, health care institutions, etc.

Conclusion:
